Our fitness center is a wonderful amenity for Autumn Woods owners and their guests. The fitness center is accessible to our owners 24/7. You'll need a key to enter after hours. Please note that the gym is only available to those residents who are 18 year or older or to those under 18 who are in the company and under the supervision of an adult.

Proper clothing is required so please be sure to wear a shirt and athletic footwear. If you would like a key to access this facility, you may purchase one with proof of residency from the property manager at the clubhouse for \$10 (checks only).

From The Guard House

Our Autumn Woods guards do a spectacular job every day but they would like to remind our owners they are contracted to man our gate

house and screen visitors to the property and **NOT** to provide concierge service to Autumn Woods' owners. With that understanding, please know the guardhouse does not accept packages on behalf of owners. They will not relay messages to a third party on behalf of owners. Nor will they run errands or leave their post to attend to owners' problems. If you have an emergency or are witness to a crime, please call the Collier County Sheriff's Department or 911. If you have a problem that is property related please call the property manager at (239) 596-9634.

Visitors: If you are expecting a visitor, delivery or are having some work done at your home, please call the automated visitor access line: **(239) 594-3151**. When prompted, leave the name and arrival time of your expected visitor. This message will automatically be entered into the guards' system and will be retrieved when your guest stops at the guardhouse. Please know that all visitors will be asked for a drivers license before being granted access to the property. All other guardhouse numbers are for information only and may not be answered right away.

Vendor and Contractors: Commercial contractors are allowed on property only between the hours of 7:30am and 5:00pm Mondays through Fridays, 9:00am - 5:00pm on Saturdays with **NO** contractors allowed on Sundays or Holidays.

It Shouldn't Need To Be Said...

- **Don't Dump in the Preserves** - Please do not discard your refuse in the preserve areas around Autumn Woods. Not only is this unsightly and enormously inconsiderate of your neighbors, it is also illegal and punishable by a \$500 fine in Collier County. If you look closely during your nature walks, you might spot one or two wilderness cameras installed throughout the property. Should we capture someone on these cameras dumping debris or vandalizing our property, the evidence will be turned over to the Collier County Sheriff's Department.
- **Vandalism is Everyone's Problem** - Not to insinuate a connection... but those times when schools are not session is when we see a spike in vandalism around the property. I would encourage all Autumn Woods owners, especially around the holiday's to be alert, to take pictures of any problems and report any incidents immediately to the Collier County Sherriff's Department and the property manager. Parent's who's children are identified as being responsible for damage, wholly or in part, can expect to be billed for repairs.
- **Gate Damage** - If you don't know by now, cameras are everywhere. Accidents Happen. We understand. However if you accidentally drive through one of Autumn Woods Gates, cause damage, drive away and fail to report it, understand it will be recorded on camera, it is a crime and we will be contacting you.
