Rules and Regulations for Use of Social Rooms

 - f. The resident reserving the location is responsible for cleaning and the condition of the area after the party. **No holes on walls, or use of tape when decorating**.
 - g. NO PARKING ON THE GRASS!!
 - h. All Deposit Checks to be return must be picked up in seven (7) days after scheduled event. After seven (7) days checks will be destroyed.

No smoking permitted ANYWHERE in the building.

No animals permitted ANYWHERE in the locations. (Exception: Vision-impaired Assists)

An inspection of the area will be made prior to and following each event.
